§1 Subject Matter 1. The Organizer facilitates participation in trips or training camps involving skydiving-related activities. 2. The Organizer itself does not provide training or skydives. 3. All sporting services are provided exclusively by independent instructors or local drop zones.

§2 No Training Contract with the Organizer 1. Contracts for skydiving services are concluded solely between the Participant and the third-party provider. 2. The Organizer acts solely as a facilitator and assumes no responsibility for the quality, safety, or proper execution of such services.

§3 Health and Personal Responsibility 1. The Participant represents and warrants that they are physically and mentally fit to participate. 2. Participation is at the Participant's own risk. 3. The Participant agrees to have any health risks assessed by a physician prior to participation. 4. The Participant agrees to indemnify and hold the Organizer harmless from any claims arising from health-related issues.

§4 Organizer Liability 1. The Organizer is only liable in cases of intent or gross negligence. 2. The Organizer assumes no liability for sport-specific risks or errors of third-party providers.

§5 Risks of Skydiving The Participant acknowledges that skydiving is a high-risk activity that may result in serious injury or death, and assumes all associated risks.

§6 Payment and Settlement 1. A prepaid account may be used. 2. The Organizer settles third-party services on behalf of the Participant. 3. Remaining balances are refunded after the event.

§7 Photo and Video Recordings The Participant consents to the use of photos and videos for marketing and documentation purposes.

§8 Acknowledgment of Event Description & GTC 1. The Participant expressly confirms having read, understood, and accepted the event description published on the Organizer's website. 2. The Participant expressly confirms having read, understood, and accepted the Organizer's General Terms and Conditions (GTC).

2. This consent includes authorization for global online and print distribution.

§4 No Compensation Required

1. The Participant/Contributor understands and agrees that they will not receive financial compensation for the use of the submitted material unless otherwise agreed in writing.

§5 Indemnification
